





WHEREAS the Grantor plans to implement **NTEP (National Tuberculosis Elimination Programme)** the partnership option

1) DRTB centre through the Grantee

AND WHEREAS the Grantor has agreed to engage the services of the Grantee, subject to the terms and constitution as hereunder.

- 1) The post of senior Medical Officer and Other as mentioned in NGO/PPP guidelines and approved in PIP will continue from (National Tuberculosis Elimination Programme) as it is.
- 2) No separate remuneration of senior Medical Officer and other staff will be provided to the grantee under the NGO PP head.
- 3) No amount for maintenance of civil work shall be provided to the grantee
- 4) The grantee must ensure availability of Physician /Pulmonologist round the Clock.
- 5) Separate designated clinic and ward must be available and should comply with the National guidelines for air-borne infection control for outdoor patients and indoor patient's settings.
- 6) Relevant specialists like Psychiatrist, Dermatologist, etc... should be available for linkage of services.
- 7) Management of adverse drug reaction should be done as per Programmatic Management of Drug Resistant TB (PMDT) guidelines-2019
- 8) Physician and Nursing care should be made available for indoor DR TB patients all the time.
- 9) Recording and Reporting should be made available as per the guidelines.

**10) Grant –in Aid:**

- 1) DR TB Treatment centre and Nodal DR TB Treatment centre (Indoor) <sup>Maximum: 7 days</sup> Rs 10,500 per patient (i.e 7 days\* Rs.1, 500 per day= Rs.10, 500 and Rs1,500 includes Bed Charges, Breakfast, Meals, Consultation charges and Pre Treatment Evaluation Test.
- 2) **Period of co-operation:** The PPP Partner agrees to perform all activities outlined in the guideline for partnerships in above mentioned area. The duration of cooperation will be from **01/04/2024** (dd/mm/yyyy) to **31/03/2026** (dd/mm/yyyy) or the day of the starting the activity / function whichever is later.
- 3) The contract can be terminated by the District Health Society / State Health Society or the PPP Partner any time with one month prior notice. The Contract will automatically end on the last day of the contract if not renewed.
- 4) Terms, conditions and specific services during the period of the MOU.
  - A. **District /State Health Society shall**
    - i. Provide financial and material support to the NGO / PP for carrying out the activities as mentioned in the terms and conditions above.

- ii. Provide relevant copy of technical guidelines, updates, manuals & circulars, Etc.
- iii. Provide NTEP drugs, logistics and laboratory consumables for use as per NTEP Policy as outlined in the partnership guidelines.
- iv. Periodically review the performance and activities being undertaken by the NGO/ PP Partner.

**B. The NGO/Private Provider / PPP:-**

- i. Perform all activities as agreed upon and signed under the partnership option MOU.
  - ii. Submit utilization certificate indicating expenditure during the quarter and available unspent balance to the respective State /District Health Society on Quarterly basis.
  - iii. Maintain adequate documentation of as per NTEP policy which is mentioned under the partnership option. On completion of tasks in the said project the Grantee will furnish to the Grantor a copy of an administrative /yearly report covering the details of project activities and studies undertaken by it. The Grantor shall have a right to call upon the Grantee to furnish such additional supplementary reports, or other documents, papers or writing as in the opinion of the Grantor are necessary or proper in connection with completion of the project
  - iv. Submit Quarterly Performance report to the DTO/STO.
  - v. The Grantee shall not delegate, transfer or assign sublet this MOU in whole or in part or otherwise, the obligations under this MOU to any person, firm or company or any other institution/organization without obtaining the prior Written approval of the Grantor.
5. Grant-in-Aid Fund shall be released by the respective health society in the name of the NGO/Private Provider/ PPP Partner for initial six months and subsequently biannually, within 30 days of the satisfactory completion activities and submission of required documents. The NGO/Private Provider will submit utilization certificate indicating expenditure during the particular quarter and available unspent balance to the respective State / District Health Society on Quarterly basis. The subsequent release will depend on the unspent balance and committed liability (if any).
6. **Fund Management:** Funds under this MOU shall be placed at the disposal of the Grantee in separate account opened by it, subject to its furnishing to the Grantor A letter of commitment containing such conditions as may be approved by the Grantor from the bank that the bank shall not exercise a lien over the said account or may right to set off or adjust any amount due to payable under any loan or credit arrangement which the Grantee may be having or may have with the bank against the amounts standing to the credit of the Grantee in the said amounts. The Grantee shall install and maintain separate books of accounts on cash basis accounting along with proper vouchers for expenditure incurred and with details of outstanding liabilities, if any. The Grantor shall have the right to inspect by its authorized officers of independent agencies the books of accounts and other records relating to the project fund kept by the Grantee any time during the agreement period or thereafter.

**7. Grievance Redressal Mechanism:**

All grievances will be addressed within a period of thirty days by DTO/STO of the concerned district/ states. Final decision will rest with state/ district health societies. Annual review would be a platform for addressing grievance of PPM partners.



If the Grantee at any stage decides that the Grantee has mis - utilized the amounts (or any part thereof) already received from the Grantor or has fraudulently claimed any covenants, stipulation or obligations hereunder a commits a breach of any of the terms, conditions or provision of this MOU on its part to be observed and performed, or it at any stage reasonable ground exist to apprehend the breach of the terms and condition of the MOU in future or that the continuance of this project 14 may be prejudiced or be in jeopardy he/she may revoke this MOU wholly or practically and ask the Grantee to refund the amount received till then along with interest accrues, if any after giving at least fifteen days' notice and an opportunity of being heard to the Grantee

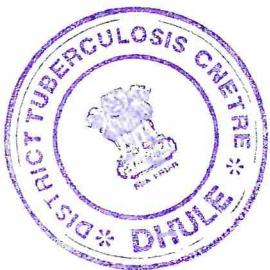

**ACPM Medical College & Hospital Dhule** having its registered address located at Hutatma Shirish Kumar Nagar, Sakri Road, Dhule, Tal. Dist.- Dhule, Maharashtra, India Pin Code: 424001

Collectively referred to as the "Parties" and individually as a "Party".

### WHEREAS:

- A. PURE Foundation is a not-for-profit state-of-the-art research institute dedicated for research and education in the field of chronic respiratory diseases with focus on Obstructive Airways Disease. It conducts community based epidemiological studies, and academic clinical research.

**NOW THEREFORE**, the Parties agree as follows:

#### 1. Appointment, Scope and Rights:

- a) ACPM Medical College & Hospital and PURE shall agree to collaborate on common projects and undertake all responsibilities as specified in Annexure A. Any changes in responsibilities shall be agreed in writing by the Parties.
- b) PURE's responsibility in the research project being conducted in collaboration with ACPM Medical College & Hospital is to be responsible to design the scientific study protocol, training of the field staff, ensuring quality assurance of the data collected, data management, data analysis and publication and ACPM Medical College & Hospital will be responsible to ensure timely participant recruitment and ensuring data completeness
- c) The ACPM Medical College & Hospital, hereby agrees to grant to PURE access and right to use any data / results / findings / observations / analysis or any other information that is

derived from, either directly or indirectly, from the data collection activity undertaken by ACPM Medical College & Hospital.

d) During the course of the Research Project, the ACPM Medical College & Hospital shall communicate with PURE's Research Scientist/Project Coordinator. The Research Scientist/Project Coordinator shall be responsible for coordinating with the ACPM Medical College & Hospital with regards to the timely completion of the activities. PURE shall ensure that the Research Scientist/Project Coordinator shall always be available for the same.
