I am directed to state that the Board of Governors at its meeting held on 25.02.2019 considered the Compliance Verification Assessment report (26.11.2018) along with the Council Assessor's Report(s) (May, 2015 & 03.03.2016 & 23.09.2016, 07.04.2017, 28.12.2017) and compliance dated 23.04.2018 submitted by the college authorities on the standard of examination and other teaching facilities for Renewal of recognition of MD (General Medicine) qualification for 04 seats at A.C.P.M. Medical College, Dhule granted by Maharashtra University of Health Sciences, Nashik and decided as under:-

"The Board of Governors considered the Compliance Verification Assessment Report (26.11.2018) along with the Council Assessor's Report (May, 2015 & 03.03.2016 & 23.09.2016, 07.04.2017, 28.12.2017) and compliance dated 23.04.2018 submitted by the college authorities together with the recommendations of the PG Expert Group (BoG) and decided to recommend to the Central Government that the recognition of MD (General Medicine) qualification for 04 seats granted by Maharashtra University of Health Sciences, Nashik in respect of students being trained at A.C.P.M. Medical College, Dhule be renewed.

"The Board of Governors further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course."
