Mr. Dhruvik Ponkiya has in writing stated that some of his batch mates and seniors used to tease her. All the other boys as such have denied their involvement but have stated that the same would not be repeated and they are ready to apologize.

Himangi Jadhav, Manika Sharma, Garima Shoora, Pranali Rajput, Ria Dhaka, Deepak Gaikwad and Shridivi Thote have in writing stated that they are a witness to the harassment being meted out to Radhika since almost last 8 months.

The committee has taken a very serious view of the complaint but decided not to cause a slur to them & their career or liberty. It was decided that the police complaint need not be done.

The punishment decided is
